Congratulations on your engagement! We are very pleased you have chosen us to be a part of your special day. Please review our bridal terms and conditions listed below. Let us know how we can make your day the most enjoyable experience.

Securing your date

Your wedding date and services will be reserved when we receive the signed contract and deposit. All services are made on a first come first served basis.

Deposit

A fifty percent (50%) deposit is required to hold the date and time scheduled. Your date will be secured on the receipt of your deposit.

Payment

The remaining balance is due the day of your services. Prices are subject to change as services may be added or upgraded. For your convenience we will calculate an automatic 18% gratuity. On-site fee will be added based on mileage, equipment transport and stylists required. We accept the following forms of payment: Mastercard, Visa, Discover and American Express. The remaining balance due will be charged on your credit card on file at the end of the day.

Changes to contract or appointments

Any changes or additions to the services must be submitted to brightsalon@gmail.com as soon as possible but no later than 7 days prior to the event date. Additions are subject to availability.

Cancellations

Cancellations may be made via phone or email. Services cancelled prior to the event date will be refunded the deposit less twenty percent (10%). Cancellations made 30 days or less will be refunded the deposit less thirty percent (20%). Any cancellations made less than 7 days notice will be charged the entire cost of the canceled services.

Late arrivals

Tardiness results in scheduling and service conflicts for you and our other clients following your appointments. If a wedding party is late for their scheduled service, stylists may or may not be able to accommodate their new arrival time. We apologize for any inconvenience but we must follow this policy out of respect for our stylists and other clients.
